To apply, complete the following steps for both need and non-need based grant funding and for loan consideration. Please type or print clearly in blue or black Complete Section A. 2. Have your child care provider complete and sign Section B. Use separate forms if you employ more than one provider. 3. Complete Section C to be considered for need-based aid. 4. Complete and sign Section D. Select the type of aid program you are applying for: Community Based Care (CBC) Grant Campus Affiliated Care (CAC) Program The GSCCG (Graduate Student Child Care Grant) Program is available to all graduate and profe with children, regardless of need. If applying for the GSCCG award only, SECTION C is not required. For eligible students, the CBC or CAC program may be available to supplement the GSCCG award. Under the CBC program, additional funds of up to\$300 may be awarded for the first child and up to \$900 for each additional child.

Graduate Student Child Care Grant Fact Sheet

Who is eligible to receive the grant?

Graduate and Professional students enrolled full-time in a UC Davis graduate or professional degree program or one quarter while on filing fee. If you are on filing fee status, you must submit verification.

- Have dependent children 12 years old or younger.
- Incur child care expenses.

What is a "Graduate Student"?

Eligible Students:

- Academic Graduate Students
- Professional Degree Program Graduate Students

Not Eligible for GSCCG:

- Undergraduate students
- Medical and Veterinary Residents (House Staff)

How much is the grant?

The GSCCG is a per UC student, per quarter flat award of up to \$600. It is not based on financial need and all graduate students with documented child care are entitled to this grant. You will be reimbursed for actual care, if your care does not reach \$600 for the quarter you will not receive the surplus.

What if both parents are graduate students?

Because this money is tied to the graduate student and not the child, two graduate student parents can receive funds for the same child's care, just not the same documented actual hours of care.

Receiving funds:

UC Students will have funds deposited into their student account to pay/reimburse the child care provider of their choice. This includes family child care homes, centers and nannies.

Does this affect other Child Care Funding?

- All graduate students with child care expenses should apply for the GSCCG. The GSCCG is *not* a need based program.
- If the graduate student(s) is/are receiving GSCCG, they
 may be eligible to receive the Campus Affiliated Care
 (CAC) Subsidy. Eligibility criteria in CAC are:
 - Children must be enrolled at one of the oncampus child development centers.
 - Second parent work/school at least 20 hours per week to establish a need for care.
 - * Income Eligibility: Annual income must be under \$48,000 for a family of two, \$54,000 for a family of 3, \$60.000 for four, \$64,000 for a family of five, and \$69,600 for a family of six.
- In addition to the GSCCG, a graduate student who demonstrates financial need may be eligible to receive a supplemental grant through the Community Based Care grant (CBC). This program provides a grant up to \$900 per child minus any funds received through the

How and when to apply:
